

Arab "Mahrajan" (Nonfood) Vendor Agreement Arab American Cultural Center of Oregon

EVENT LOCATION:

Oaks Amusement Park, Area 9 7805 SE Oaks Park Way Portland, OR 97202

WHEN:

Sunday, September 3, 2023 11:00 a.m. to 7:00 p.m.

SET UP:

Set up begins at 9:00 am. Each vendor will be provided 1 table and 2 chairs, which are assigned upon receipt of this signed agreement. A limited number of canopies will also be available for vendors. You must coordinate with the event organizers if you require more than one canopy. You may also bring your own canopy. If you choose to bring your own canopy, please let us know in advance. Note that the festival takes place in an outdoor venue, in September, and there is relatively little shade. Table locations and canopies will be assigned on a first-come, first-served basis, on the day of the festival.

VENDOR COMMITMENT:

Each vendor must be open and operational from 11 a.m. to 7 p.m. during the festival.

VENDOR FEE:

The fee for non-food vendors to participate in the festival is \$75. There is no cost for nonprofits to participate as vendors. or other similar items are **NOT ALLOWED** at any of the tables. AACCO reserves the right to remove or prohibit any props or materials in its sole discretion.

Each vendor must have a representative present at its table at all times. Please note that all products and displays are at the sole expense of the vendor.

SECURITY:

You agree that AACCO is not responsible for any theft or lost, tampered, or broken goods. Each vendor is responsible for its own goods and merchandise.

FOOD:

Vendors may sell dry goods, non-food items, etc. Vendors <u>ARE NOT ALLOWED TO GIVE</u> <u>AWAY FREE FOOD, SAMPLES, OR TASTES</u>. Inspectors may be visiting the event, and those who give away free food without a permit will be subject to fines and removal from the festival. AACCO is not responsible for any fines or other liabilities incurred as a result of any vendor's noncompliance with these regulations.

TAKING CARE OF THE PARK:

Please take care of Oaks Park! Care must be given to the park grounds to ensure there won't be any damages from festival operations or activities. We appreciate your cooperation with us!
